PwC Vietnam's HackaDay 2017: Cyber security competition for university students

Hanoi, 9 September 2017 – Today, PwC Vietnam has successfully organised a cyber security competition for undergraduate students titled 'HackaDay 2017'. The contest drew 25 teams who competed in PwC's offices in both Hanoi and Ho Chi Minh City, and a guest team joining online from Malaysia.

The event also saw the attendance of representatives from the Vietnam Information Security Association (VNISA), the Information Technology Department under the State Bank of Vietnam, and the Vietnam Computer Emergency Response Team (VNCERT).

With an aim to raise cyber security awareness among Vietnamese youth and nurture young talents in information technology, PwC Vietnam is proud to be the first South East Asian member of the global PwC network to bring this competition to the local youngsters.

HackaDay 2017 took the contestants through several challenges, such as reverse engineering, software vulnerability exploitation, and hacking web services and programm logic like SQL injection, XSS, Session Hijacking, etc. With the highest score and the earliest completion time, the 'L0s3r' team consisting of Phan Thanh Duy, Pham Hong Phi and Bui Minh Tien Dat from the University of Information Technology - Vietnam National University in HCMC became the final winner and received a three-month internship at PwC Vietnam plus a cash prize.

Robert Trong Tran, Cyber Security and Privacy Leader at PwC Vietnam said:

"We hope that the competition has helped to connect different IT talents in Vietnam and proved to be a meaningful, exciting and memorable experience for all the students."

"Cyber security is one of the biggest challenges of our times. We believe that it is essential to play a part in helping young people gain the necessary knowledge and skills to deal with the rapid changes of the tech world. This is because they will be the main forces driving the evolution of cyber security awareness and capabilities in the whole society," he emphasised.
